This year has been a huge year for organ donation, with an opt-out system now in place in England. The new law is already saving and transforming lives, but we need to continue to make people aware of the law change, to help save more lives.

All adults in England will be considered as willing to donate when they die, unless they have recorded a decision not to donate, are in one of the excluded groups or have told their family they don't wish to donate. Adults covered by the change will still have a choice whether they want to be an organ donor and their families will still be involved before organ donation goes ahead.

It's important you not only register your decision on the NHS Organ Donor Register but share it with your family or closest friends too, to give them the certainty to support your decision at a difficult time.


Every day across the UK someone dies waiting for a transplant - you could save or transform up to nine people's lives by donating your organs when you die and help even more people by donating tissue, such as your heart valves, skin, bone, tendons and corneas. We're enormously grateful to the people across County Durham and Darlington who have donated organs and, of course, their families. Last year we unveiled our memorial sculpture at DMH to record and honour their generosity and courage. We're moving forward with plans for a similar memorial at UHND.

CDDFT AKI Specialist Nurse Service



To support the new AKI Specialist Nurse Service, a collaborative agreement has been reached between CDDFT and South Tyneside and Sunderland NHS Foundation Trust (STSFT) for twice weekly visits to University Hospital of North Durham for 52 weeks a year from 3 consultant Nephrologists.

The team comprises of Will Hinchliffe, Saeed

Ahmed and Shalabh Srivastava who have all trained in the Northern Deanery. Dr Ahmed has over 15 years of consultant experience and Dr Hinchliffe and Srivastava contribute a further collective 10years.

Dr Srivastava holds honorary lecturer status at Newcastle University and Dr Ahmed has a senior leadership role with STSFT as CD of medical specialities. Dr Hinchliffe will be leading by providing at least 25 weeks a year and holds clinics twice a week at the Durham Treatment Centre in Belmont for his patients that live in County Durham.

They are all excited to commence the service from Monday 14 September 2020 and will be visiting on a Monday afternoon and Thursday mornings. They can be reached by email at: stsft.renalreferral@nhs.net

For Darlington Memorial Hospital, a similar arrangement is being considered with James Cook University Hospital that is expected to be finalised in the coming weeks.

StaffNet / SharePoint upgrade

The trust is in the process of moving to our new version of StaffNet, including the community areas.

The current platform, SharePoint 2010, is end of life and is not supported from October this year. The move to the new platform, SharePoint 2019 is required to maintain the security and reliability of the system; the newer platform also offers additional functionality whilst being easier to develop and maintain. The move has been broken down into three key stages:

- Stage 1 the migration of all current active sites, community areas and document repositories into the new version
- Stage 2 the development and replacement of bespoke functionality which has had to be replaced by alternatives in the new version
- Stage 3 further developments and transition into the standard support arrangement

The initial development of the new structure has completed and is currently undergoing user testing; once agreed a series of content migration sessions will take place to transfer all existing content into the new environment.

The final migration and subsequent go-live of the new areas will take place this month, with further timescales to be agreed with the supplier. Once these are known they will be communicated to all staff members.

To make the transition as smooth as possible we ask the following:

- No current sites (or sub-sites) should be re-named
- No current document folders should be re-named
- No further web parts or lists should be added or created

• Rather than re-name current documents, a new version should be uploaded Training materials are being developed to support users to make the transition to the new platform, these will be available for go-live.

Please note that due to the migration, any requests for new sites or developments within the current intranet will be paused, these will be picked up after the new StaffNet goes live.

Important safety message - Shotley Bridge Hospital car parking

A message from Michael Peace, Car Parking Manager:

It has been brought to the Trust's attention that Ambulance Crews at Shotley Bridge Hospital are unable to use and/or are experiencing difficulties accessing the ambulance bay at the Tower Block Entrance, as the road is often blocked by vehicles parked on double yellow lines, which also reduces the width of the turning area. This is having a detrimental impact on patient transfers to and from Ward 2.

In addition, colleagues are asked to refrain from parking on the main road and pavements surrounding the hospital site as this causes difficulties for pedestrians and vehicles who require access to housing.

All colleagues are asked to ensure that they park their vehicles in designated parking bays only.

Coroners Management Portal

We recently brought you a reminder about referrals to the HM Coroner, however we've been made aware that they continue to receive referrals using the old referral form and email.

A reminder to all medical staff: All referrals to the HM Coroner must be through the Coroners Management Portal. Failure to do this will lead to a delay for both the patient and family and impact on turnaround times and the risk of errors during this process: <u>https://durham-portal.coronersconnect.co.uk/</u> or access via StaffNet from the Systems drop down box: Coroner case management.

The username and password are available from the Ward looking after the patient. Please **do not** complete the old referral form and email the Coroner.

Manual handling practical face to face training for patient handlers

If your Practical Manual Handling competency (NHS|CSTF|Moving and Handling -Level 2 - 3 Years) has expired (i.e. turned red) on ESR, you should now renew this competency for 12 months by completing one of these eLearning module:

- 439 eLearning Manual Handling Certification (RGN AHP HCA) 2020 This eLearning is for all patient handlers, including porters.
- 439 eLearning Manual Handling Certification (MEDICS ONLY) 2020 This eLearning is for senior medical staff

Once completed, you will need to attend one of the face to face classes before the 12 month expiry. Places on face to face sessions are being allocated by course bookings on a priority basis. Staff and Bank workers that have started with the Trust

since March will be allocated places first, followed by all other staff and Bank workers based on the expiry date of the competency.

Learning and Development are offering two new training courses to help support people to better understand mental ill health and promote mentally healthy workplaces, these are:


- Mental Health at Work specifically aimed at those who manage or supervise staff

Awards & accolades



Last week, on Friday 4 September the Health Service Journal (HSJ) held their annual Value Awards. Initially planned for July, the ceremony was postponed and ultimately ended up being held on Twitter!

The #TeamCDDFT Dermatology team and Partners had been nominated for an award for the work done in rapidly implementing a service change that has seen a huge benefit to patients suspected of having skin cancer.

This partnership project between CDDFT, local partner CCGs and an independent company, Consultant Connect, covers a population of over one million people, to which CDDFT provides a sub-regional dermatology and plastics service. Instead of sending a traditional two-week-wait (2ww) referral for an out-patient skin cancer appointment, GPs now send photos of the lesion with an eRS referral. A consultant dermatologist views the images and the referral details within one working day and triages the patient into the appropriate service. The project has the full support of the local cancer network, the North East Cancer Alliance.

The team did not win the big prize, but the department is very proud of being nominated and as a Trust we're hugely grateful to everyone involved.
