National news

First impact report published by VCS Emergencies Partnership

The Voluntary and Community Sector Emergencies Partnership is made up of a range of organisations from within the sector, including VONNE, with the aim of improving coordination at national and local levels before, during and after emergencies such as the Covid-19 pandemic.

Bringing together local, national and global expertise from the sector, the partnership, which has now issued its first report covering the period between March and August this year, aims to help people prepare for, respond to and recover from emergencies, so they can rebuild their lives.

Kruger review broadly welcomed by the VCSE sector while job loss warning follows news of treasury support to replace furlough scheme

The VCSE sector broadly welcomed the ideas put forward in the Kruger review into how the government might make the most of the voluntary sector in the UK's recovery from the coronavirus pandemic.

Danny Kruger, the Conservative MP for Devizes, made a raft of recommendations including that the government should seek to unlock £500m from the National Fund to support the sector, and establish a £2bn endowment fund to support disadvantaged communities.

Although the measures were welcomed, there remains some anxiety over whether and when the government might adopt the recommendations.

Meanwhile, VCSE sector representatives have warned that the chancellor's new Job Support Scheme will do little to protect the sector from long-term financial damage.

Social Investment Business to deliver £3 million Community Business Renewal Fund

Power to Change, the independent trust that supports community businesses in England, has this week unveiled the Community Business Renewal Fund, a £3 million unrestricted grants programme to help established community businesses in England to assess, diversify and strengthen their operations.

Opening on November 3rd, the fund will provide grants between £10,000 and £20,000. Applications are open to all community businesses that were financially viable before the pandemic, but priority will be given to those supporting people at higher risk from Covid-19, those operating in areas of high deprivation, or working closely with communities of colour.

Apply to the Postcode Recovery Fund

The Postcode Recovery Fund has been created to support charities to develop innovative solutions that address the many issues affecting people as society recovers from the effects of the pandemic.

A total award fund of £3m will be given to charitable organisations to deliver projects in Great Britain in 2021-2023. Charities can apply for up to £1m for a project that addresses a systemic societal issue related to the pandemic.

Funders are looking for impactful and original projects that can demonstrate a clear link to the effects of the pandemic across the following six funding priority areas:

- Educational inequalities
- Homelessness
- Domestic Violence
- Health and wellbeing
- Social exclusion and isolation
- Poverty

Regional news



The Local COVID Alert Level is set to HIGH. This alert level applies to areas where the infection rate is high and the risk of transmission is significant. The alert level is based on the following criteria:

Category	Guidance
Social Contact	1 household / bubble indoors. Rule of six outdoors.
Weddings and Funerals	Up to 15 guests for weddings and up to 30 guests for funerals. 15 for receptions, wakes and related ceremonies.
Overnight Stays	Overnight stays permitted subject to social contact rules.
Working from home guidance	Work from home where possible.
Shopping and Retail	Open.
Leisure and gyms	Open.
Hospitality	Open with some restrictions including 10pm closing time and table-service only.
Entertainment and tourist attractions	Open, except nightclubs and adult entertainment.
Education	Schools, FE colleges open. Universities must reflect wider restrictions.
Healthcare Services	Open.
Residential Care	Closed to external visitors other than in exceptional circumstances.
Travel and Transport	May continue to travel to open venues, but reduce number of journeys where possible. Avoid travel into Local COVID Alert Level Very High areas where possible.
Sporting Activity	Organised sport / licensed physical activity allowed in outdoor settings. Indoor organised sport must follow social contact rules (other than youth or disabled sport).
Worship	Open, subject to social contact rules.
Childcare	Registered and wraparound childcare. Supervised activities permitted in private homes. Children's groups permitted. Childcare bubbles for under 14s.
Youth Clubs and Activities	Permitted.

The new coronavirus rules – clarity on the three-tier system

Following the introduction of the new three-tier system across England to help curb rising Covid-19 infection rates, the government has clarified what we can and can't do according to our new 'high level' classification.

North of Tyne Combined Authority sets out local recovery plan

North of Tyne Combined Authority has announced its five-point plan for recovery from the coronavirus pandemic, along with its proposal to government, outlined in a short animation, asking for more investment to enable a quicker recovery for residents, businesses and communities – and a better and greener future.

A more inclusive economy forms the backbone of the proposals to help North of Tyne become the area that travels fastest towards net zero emissions and new green jobs.

The authority has also launched a new campaign, [#CrowdfundNorthofTyne](#), through which local groups can get up to £5,000 towards their community crowdfunding campaigns. The deadline to get involved is November 3rd.

A reminder to #DoYourBit to help tackle flu

Those most at risk from flu are also more vulnerable to Covid-19, so the NHS is asking you to #DoYourBit to protect individuals and communities by encouraging people to get the annual flu vaccination.

The jab is free to anyone at increased risk from the effects of flu, including:

- those aged 65 and over
- pregnant women
- those with certain medical conditions (aged six months to 64 years)
- those in long-stay residential care or another long-stay care facility
- those receiving a carer's allowance
- the main carers of elderly/disabled people whose welfare may be at risk if they fall ill
- those that live with people at high risk of Covid-19 (on the NHS shielded patient list), or that expect to be with them on most days over winter
- NHS and social care workers
- children aged two to three years
- all primary aged school children and Year 7 pupils.

Equity, diversity and inclusion

Moving from non-racist to anti-racist

Acevo and Voice4Change England released [*Home Truths: Undoing racism and delivering real diversity in the charity sector*](#) in June, the final report in the year-long *Making Diversity Count* project.

The report, part of wider awareness raising and activist work being done by many, including Charity So White and the Black Lives Matter movement, frames the conversations around racism in the charity sector with an acknowledgment that it's a significant unresolved issue.

There is an increasing understanding of the distinction between being non-racist and becoming actively anti-racist, and VONNE, together with GLT Partners, is hosting an event on November 26th to provide a space for the North East VCSE sector to have these conversations.

VONNE round up

Over the past few weeks VONNE has:

- Attended the Cleveland and Darlington Strategic Coordination Group to ensure the voice of the VCSE sector is included in Covid-19 crisis responses.
- Worked with Digital City Teesside University to develop a digital offer to Tees Valley VCSE organisations, supporting them to access funds and expertise (more info in the Digital and Innovation section below).
- Contributed to deciding which projects receive funding from the Durham University Impact Acceleration Account, seeking to ensure university research has an increased impact on local communities.
- Attended meetings as members of the North East Child Poverty Commission.
- Supported the Climate Action Network of the Integrated Care System (ICS) to develop its Climate Change Sustainability Strategy.
- Hosted the second North East & North Cumbria VCSE Partnership Forum meeting themed around the ICS health strategy, at which more than 50 participants shared their top organisational and beneficiary challenges in the current pandemic. There

Gift Aid automation project kicks off

Charities, academics and tech companies have begun a project to automate Gift Aid in a bid to unlock millions of pounds in unclaimed tax relief, as reported by Civil Society.

The coalition, led by the Charity Tax Group, said it's designing a digital system for making Gift Aid payments, which will remove the "clunky administrative processes" that act as a barrier to some giving. Charities involved in the *Future of Gift Aid* project include Cancer Research UK, Sue Ryder and the Children's Society, working alongside academics at leading universities and companies like Streeva and JustGiving. The project is still looking for a bank to join the work.
