A roadmap recap

As announced this week, from March 8th we may see lockdown restrictions begin to lift as part of a four-step plan being implemented across England.

All the indicative dates in the roadmap are subject to change, depending on the scientific data available at the time, with a minimum of five weeks between each step to include a week's notice to enable organisations to prepare once the government has confirmed its decision.

Priority has been given to children and students to allow them a safe return to face to face education, as well as childcare and supervised activities. At this point, if the evidence supports the progression out of lockdown, people will also be allowed to leave home for outdoor recreation and exercise with their household or support bubble, or with one person from outside their household. Care home residents will be allowed one regular visitor.

No earlier than March 29th, outdoor gatherings of either six people or two households will be allowed, including in private gardens, and outdoor sports will once again take

place. We must stay at home until at least March 29th, after which many restrictions will remain and people should continue to work from home and minimise journeys where possible.

Further details of support available to particular groups will be set out in the budget on March 3rd, and in the meantime, a series of explainer videos and social media assets have been created for organisations to use.

Minister says there are no further plans for emergency funding for VCSEs

Baroness Barran, the minister for civil society has confirmed the government has no plans for more dedicated emergency coronavirus funding despite VCSE leaders pushing for further support.

The minister said she was aware of “concerns in the sector” but felt the government’s roadmap plans allow organisations to think about public fundraising and reopening charity retail again.

She added: "It might need to look a little bit different, but charity is nothing if not agile and creative in that regard."

The latest on climate and fairness in the south of our region

Last week, the Institute For Public Policy Research (IPPR) launched the findings of its first citizens jury on climate and nature in the Tees Valley and County Durham.

Part of the work of the cross-party Environmental Justice Commission, the report and recommendations, in the words of the jurors, highlight the strong desire of the public to participate in making decisions on the transition, as well as for public information campaigns and widespread education.

There's a strong emphasis on the need for long-term commitment and funding from central government, as well as devolution, so plans can be tailored according to local needs.

Tackling misinformation about the Covid-19 vaccination

Thanks to a huge UK-wide effort, more than 19.8m people have received their first dose of a vaccine to help protect them against Covid-19.
